



## Camp Wild Side 2017

**Who:** Children who are entering grades 1-8 in the fall.

**What:** Join us as we spend this summer at Prairie Crossing Charter School. Each two week camp session will be filled with indoor and outdoor games, team building activities, art, and more! Campers will be engaged and immersed in their surroundings through a variety of hands-on activities designed to foster leadership skills and strengthen bonds to nature and each other.

**Where:** At the Prairie Crossing Charter School Campus!

**When:** Camp Wild Side will run from 8:00 am to 3:00 pm from June 5 through July 28 in two week sessions. Campers have the option of Three Day (M, W, F) or Five Day Camps **within the same session.**

**Cost:** Five Day Camp is available for \$400 per session. Three Day Camp is available for \$300 per session\*\*. Sign up by **April 28** with a \$100 deposit. **Registrations cannot be accepted after April 28th.** Please note that should camp be cancelled due to low enrollment, all deposits will be refunded.

## Camp Wild Side 2016 Information Sheet

The following information is meant to help everyone's summer run smoothly and allows us to have as much fun as possible. Please familiarize yourself with the information in this packet. ### Location

Camp Days will begin at 8am sharp at the firepit outside the Carson Building at Prairie Crossing Charter School, 1531 Jones Point Road, Grayslake.

### Times

8:00-3:00pm Day Camp (Monday-Friday) OR (MWF)

### Drop Off/ Pick Up

Drop off time is no earlier than 8:00 am. Counselors will meet students at the firepit outside the Carson Building, **Please walk your camper to the designated drop off/pick up location and sign them into camp.** In the case of inclement weather, please walk your camper to the gymnasium located just east of the Kennicott Building (continue around the circle drive) to sign your camper in. **Pick up is at 3:00 pm. To pick up your child, please walk to the designated drop off/pick up location and sign your camper out.** Your camper must be signed out by an adult authorized to pick them up. Campers will **NOT** be released to an individual whose name is not listed on the camper's Information Sheet, unless the Camp Director has been previously notified.

### Activities

The camp staff will plan a variety of activities consisting of arts & crafts, creative drama, cooperative games, sports, theme weeks, environmental activities and more! It is our goal to have a safe, fun, and festive day camp program that your camper looks forward to joining each day!

### Communication

Camp newsletters and all other information will be emailed to the participant household on a bi-weekly basis. Please provide a current email address on the registration form found in this packet. In rare cases, a physical flyer will be send home with your child.

### Lost and Found

**Please put your child's name on everything coming to camp.** A lost and found box will be kept at the campsite. Items not claimed by the end of the summer will be donated. Please do not have your camper bring anything to camp that is valuable (including jewelry, electronic games, etc.). **Prairie Crossing Charter School is not responsible for lost, stolen, or damaged items.**

### Attendance

If your camper will arrive late to camp, leave early, or deviate from the normal schedule, please send a note with your camper. If your camper leaves early, staff will bring your camper to the Kenicott Building Office to meet you. If your camper arrives late, please bring your camper to the Kenicott Building Office and a staff member will bring them to their group. You will need to sign your child in or out at the Office when dropping or picking them up late. In the case of a known or prolonged absence, please notify staff as soon as possible.

### Behavior

A positive approach will be used regarding discipline. Staff will periodically review rules with participants. If inappropriate behavior occurs, prompt resolution will be sought specific to each individual situation. Resolutions may include limited activities and/or parent/Camp Director meetings. Prairie Crossing Charter School reserves the right to suspend and/or dismiss a participant whose behavior endangers his/her own safety or that of others.

### Walk/Bicycles

Campers who ride bikes must lock them up at the outdoor bike rack in front of the Carson Building. All bikes must be locked with the camper's own lock. Prairie Crossing Charter School is not responsible for lost or stolen bicycles.

### Sunscreen

Camp staff is not allowed to apply sunscreen onto campers. We suggest that parents use/send spray-on sunscreen and teach your camper to use it. Staff can help with spray if needed.

### Cell Phones

Campers **may not** use cell phones during the camp day since their use is disruptive to camp activities. If you want your camper to bring a cell phone to camp, it must be turned off during the camp day and kept in their backpack. If a camper is found using their phone, we will hold it and return it to your camper at the end of the day. Staff will also speak to a parent at pickup time. If your camper needs to contact you, they may ask Staff or the Camp Director. If you need to contact your camper, please leave a message with the office.

### Trash-free lunch program

We ask each camper to bring a trash free lunch and reusable water bottle every day. Eliminating paper cups can save hundreds of trees! Please write your camper's name on the water bottle & lunch container with a permanent marker.

### What to Bring to Camp

Your child should bring a **backpack** to camp each day with the following items:  
- lunch and drink - reusable water bottle - sunscreen - a healthy snack - gym shoes -

### Payment information

Payment is due at the start of each session. Accepted methods of payment include Cash, Check or Credit Card. Checks should be made payable to PCCS with your camper's name on the memo line. Camp fees will not be prorated due to non-attendance. To withdraw from a session of camp and receive a partial refund, a request must be submitted in writing by the Thursday prior to the start of the withdrawn session.
