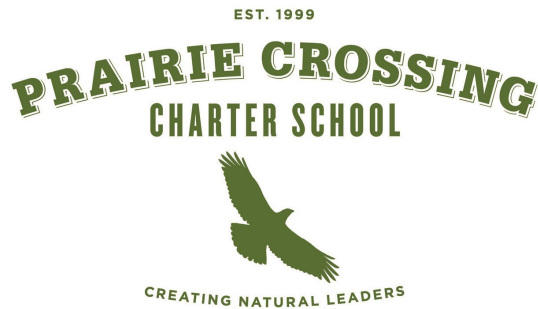

Public Comment

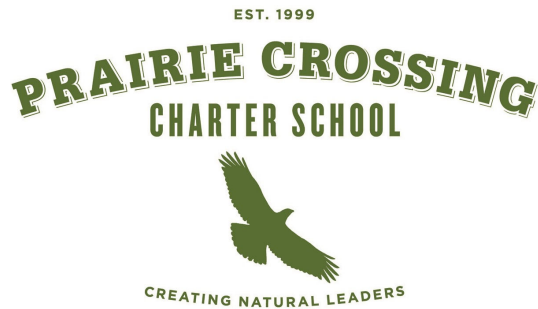
Public Present: Mila O'Neill. No public comment.
